

## Resolution No. 30 /2016 of 22 June, 2016 of the Rector of the Medical University of Lodz

# Regarding implementation of the guarantee deposit for accommodation in the Halls of Residence of the Medical University of Lodz

Pursuant to Article 66 Item 2 of the Act on Higher Education of 27 July 2005 (i.e. Journal of Laws of 2012, Item 572, with further amendments) and Paragraph 47 Item 4 Point 10 of the Statute of the Medical University of Lodz of 29 September 2011 as amended, I declare the following:

#### § 1

Each person who has obtained the right to accommodation in the Hall of Residents of the Medical University of Lodz hereinafter referred to as the "resident", for a period longer than one month, is obliged to pay a single guarantee deposit of 300 PLN, hereinafter called the "deposit".

### **§ 2**

The deposit ensures coverage of any repair costs for damage caused by the resident in a room rented to him/her or in the Hall of Residence or costs arising from unpaid charges due for using the rented area in the Hall.

## § 3

The deposit should be paid to the bank account of the Hall of Residence in which the resident will be lodged, not later than on the day of accommodation.

#### § 4

- 1. The deposit will be returned after the resident's final checkout from the Hall of Residence and deduction of a possible sum of money resulting from events referred to in § 2.
- 2. The deposit will be refunded to a designated bank account upon the written request of the resident within 14 days from the date of request submission to the Department for Undergraduate and PhD Students' Affairs.
- 3. The application form is attached as Appendix No. 1.

## § 5

The Resolution shall come into force upon the day of signature.
